

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.nowmicroplayers.com](http://www.nowmicroplayers.com) and Now Micro and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Now Micro include [www.nowmicroplayers.com](http://www.nowmicroplayers.com). The Now Micro website is an Information and Ecommerce site. By using the Now Micro website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our site, Now Micro may collect personally identifiable information, such as your:

- First and Last Name
- E-mail Address
- Phone Number
- Job Title
- Company Name
- Email Address

If you purchase Now Micro's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Please keep in mind that if you directly disclose personally identifiable information or personally sensitive data through Now Micro's public message boards, this information may be collected and used by others.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. ### **Use of your Personal Information**

Now Micro collects and uses your personal information to operate its website(s) and deliver the services you have requested.

Now Micro may also use your personally identifiable information to inform you of other products or services available from Now Micro and its affiliates.

### **Sharing Information with Third Parties**

Now Micro does not sell, rent or lease its customer lists to third parties.

Now Micro may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Now Micro, and they are required to maintain the confidentiality of your information.

Now Micro may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Now Micro or the site; (b) protect and defend the rights or property of Now Micro; and/or (c) act under exigent circumstances to protect the personal safety of users of Now Micro, or the public.

### **Tracking User Behavior**

Now Micro may keep track of the websites and pages our users visit within Now Micro, in order to determine what Now Micro services are the most popular. This data is used to deliver customized content and advertising within Now Micro to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by Now Micro. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Now Micro website.

### **Use of Cookies**

The Now Micro website may use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you. One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Now Micro pages, or register with Now Micro site or services, a cookie helps Now Micro to recall your specific information on subsequent visits. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. - SSL Protocol
